

## **Selex ES S.p.A, (Italy) Address Change**

Effective immediately, Selex ES S.p.A. will change as follows: Piazza Monte Grappa, n. 4-00195, Rome, Italy. Several Selex ES S.p.A. sites will close or consolidate activities within Italy. Due to the volume of authorizations requiring amendments to reflect these changes, the Deputy Assistant Secretary for Defense Trade Controls is exercising the authority under 22 CFR 126.3 to waive the requirement for amendments to change currently approved authorizations. The amendment waiver does not include approved and/or pending agreements.
